### 有關富健花園固定電力裝置檢查及測試工程(WR2) 暫停商場第 1-63 及 88 號舖及公眾電力供應事宜

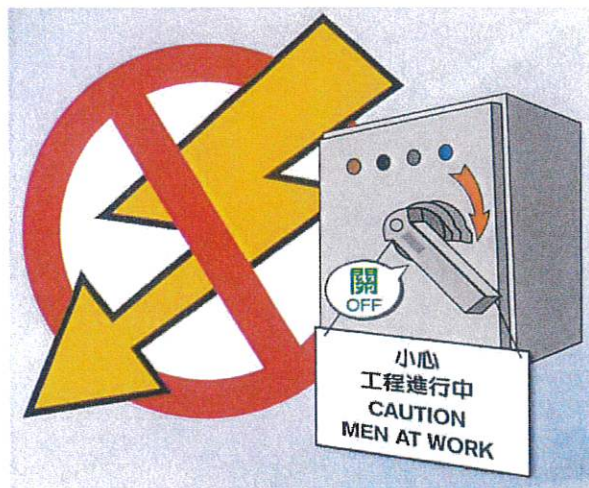

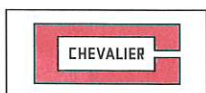

Suspension of Electricity, Water Supply, Lift Services

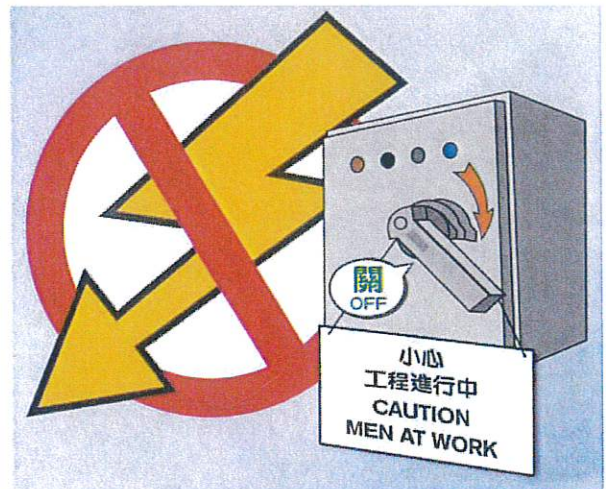
As stipulated in the Electricity Ordinance, the low voltage fixed electrical installation of the Estate that has an approved loading exceeding 100A shall be inspected, tested and certified at least once every five years. The Management hence informed all owners/occupants that the captioned inspection and testing work of WR2 certification will be conducted accordingly. In order to facilitate the progress of work, the electricity supply, fresh and flush water supply, as well as lift services will be suspended during the course of work, the details of which are listed as follows:

3. Fresh and flush water supply



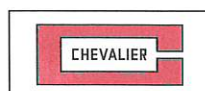
